911 TAPE TRANSCRIPTION

DATE: March 26, 2006

1                   This is Communications Supervisor, Roberta  
2 Pennicks, of the Pasco County Sheriff's Office. Today's  
3 date, May the 8th, 2006. The following conversation is  
4 recorded from master tape dated March 26th, 2006. The  
5 time is 01:20 hours.

6           OPERATOR: Sheriff's Office, what is your emergency?

7           CALLER: Yes, sir. I'm calling to report that my friends and  
8 me were walking up Grand Boulevard.

9           OPERATOR: Okay.

10          CALLER: A black Ford 4-wheel drive come through and plowed  
11 both of them over. My friend, Joe, is not breathing. I'm  
12 scared to death he might be dead. My friend, Sarah, is  
13 breathing hard. She's bleeding from --

14          OPERATOR: Tell me where you're at, sir. The ambulance  
15 is on the way.

16          CALLER: I know. I can hear the ambulance. I know it's on  
17 the way.

18          OPERATOR: I need to know where you're at so we can  
19 send a deputy out there.

20          CALLER: I'm on Grand Boulevard and Pasadena Avenue, right  
21 in front of New Port Richey -- New Port Plaza, 4809.

22          OPERATOR: 4809 Grand?

23          CALLER: Yes, sir. Fuck, fuck (inaudible).

24          OPERATOR: Calm down for a minute. We've got an  
25 ambulance on the way. They're on the way.

1 CALLER: Yes, sir. I'm sorry.

2 OPERATOR: That's all right. I understand. I just  
3 need some information.

4 CALLER: Yes, sir. What do you need to know -- anything you  
5 need to know.

6 OPERATOR: Just hang on. Let me make sure we know  
7 where we're at. 4809 Grand is where you're at?

8 CALLER: Yes, sir. I'm -- if you're on Grand Avenue, you'd  
9 leave Community Hospital. I'm about half a mile from the  
10 red light.

11 OPERATOR: Okay.

12 CALLER: I can -- I'm sitting here looking at the red light  
13 right now. I'm not --

14 OPERATOR: Take a breath for me and relax.

15 CALLER: I'm sorry. I can see the ambulance now.

16 OPERATOR: You said 4809. That number is not coming  
17 up. I'm sorry.

18 CALLER: It's New Port -- it's New Porter Plaza. It's got  
19 the (inaudible).

20 OPERATOR: I just need an address. What's the  
21 nearest crossroad you're at? Was it Pasadena, you said?

22 CALLER: Pasadena Avenue and Grand Boulevard. Yes, sir,  
23 it looks like a first responder here now.

24 OPERATOR: I don't know -- if you are not in the city  
25 limits of New Port Richey. That's what I --

1 CALLER: Pull over. Yes, sir, it was. Hey, the guy is two  
2 lights up. The guy who hit us is two lights up right now  
3 in a black Ford truck, 4-wheel drive -- the guy that hit us.

4 OPERATOR: Did he stop?

5 CALLER: No, sir, he did not. He's two lights down. My  
6 brother-in-law and friend just got here. They seen him up  
7 the road at the BP or past -- right at the BP. He's hiding  
8 behind some box they said.

9 OPERATOR: What kind of truck is it?

10 CALLER: (Inaudible).

11 OPERATOR: What kind of truck is it?

12 CALLER: It's a black Ford truck. It's a black Chevy --  
13 sorry. Black Chevy, 4-wheel drive. (Inaudible) You got here  
14 quick. That's about all I can tell you, man.

15 OPERATOR: Where is he at; on Grand?

16 CALLER: My brother-in-law just said that they seen him at  
17 the BP hiding behind a box. I don't --

18 OPERATOR: He is on Grand and what?

19 CALLER: All right. She's still breathing, but she's hard  
20 breathing? Say again. I'm sorry.

21 OPERATOR: He's on Grand by the BP?

22 CALLER: Yes, sir. That's what my brother-in-law -- he just  
23 pulled up right now. He just now told me that --fuck --  
24 that he's at the BP hiding behind some kind of box.

25 OPERATOR: On Grand?

CALLER: On Grand. My brother -- it looks like my brother-in-

1 law just went up there to stop him or keep him or something.  
2 I don't know. I really don't know, man. Please get someone  
3 up there to keep him from going to jail because I don't want  
4 nothing else happening now, man. Fuck.

5 OPERATOR: You said the ambulance is there?

6 CALLER: Yes. It arrived here now. Fire truck, ambulance,  
7 first responder is here now. Can I get off the phone now,  
8 please? Is there anything else you need?

9 OPERATOR: No. Go ahead.

10 CALLER: Thank you.

11 ROBERTA PENNICKS: The time of the following  
12 conversation is 01:25 hours.

13 OPERATOR: Pasco County Sheriff's Office, Operator
